**\*Fee Schedule** for Your Information:

90791 (53-60 min.) All First Sessions are = \$150 or as agreed upon with your EAP or Insurance

90832 (16-37 min.) = \$50

90834 (38-52 min) and 90837 (53-60 min.) = \$100 cash or as contracted at \$125 with your EAP or insurance.

Same with 90846(w/o pt) and also same with 90847 (Family)

Hypnosis *Special Topics (2 hours) = \$300*

Hypnosis Program = \$599 For Stop Smoking or Weight Loss includes a 1 hour prep. 2 hour hypnosis and a 1 hour EFT training and follow up for a total of 4 hours.

Missed appointments not cancelled even if sick or called into work are charged full cash price. Late canceled or rescheduled appointments (less than 24 hours) may be charged \$50. Only emergency hospitalizations or family death are considered excused.

Package Price – Prepay 4 visits and get the 5<sup>th</sup> one free if used within 2 weeks. (38-52 min) = \$400. This can save you money however please understand missed appointments' or late rescheduled appointments are charged.

**Conversations** on phone beyond discussing schedules are considered Urgent Care. Texting any subject other than schedule is considered counseling contact for a charge of \$2. per text. And e-mails besides schedule issues are charged a minimum of \$5. per email or more according to the time for processing into file.

I do not guarantee availability yet I am generally available and am willing to interrupt my personal schedule if you desire my assistance except when in other appointments.

Phone appointments emails and texts are NOT covered by insurance or EAP. Therefore, any communication outside of regular scheduled appointments is cash only.

Urgent Care unscheduled and phone counseling will be charged cash at a rate of \$3.00 per minute. An additional \$20 fee each will be charged after 8 pm till 7am and weekends.
